## **PROCEDURE FOR APPLYING**

Before applying, the candidates are advised to go through the admission notice published in the press and the instructions given therein carefully. Fill in the application form in accordance with the instructions given in this prospectus and the admission notice. Please ensure that no column is left blank. **Incomplete applications will not be considered and no correspondence will be entertained.**

- a) The application, complete in all respects accompanied with all the relevant documents should reach the office of the **Registrar, PGIMER, Sector-12, Chandigarh** on or before the closing date. The applications received after the closing date will not be considered and no correspondence will be entertained.
- b) The fact that an application form has been dispatched on a certain date will not be accepted as an excuse for the late submission of the application. The dispatch of the application form does not ipso-facto make the applicant eligible for admission to the selection test.
- c) Application on forms other than those prescribed for the purpose will not be entertained. If any candidate gets an application form for course different from the one asked for, he/she may submit his/her application on the same before the closing date. The application will be treated as an advance copy. The application on the prescribed form will be obtained later.
- d) The candidates who applies for the admission to Fellowship PGI under sponsored/deputed category should be regular employee of the Government Department/Institute/Medical College for the last at least three years.

## **PROCEDURE FOR APPLICATION FORM**

1. After opening the PGIMER website i.e. [www.pgimer.edu.in](http://www.pgimer.edu.in), the candidate will download the Application Form available on the website and fill up various columns.
2. After filling up all the columns, the candidate will generate Challan Form and deposit the requisite fee in any Branch of State Bank of India anywhere in India. After that the candidate will fill the Challan Form No./I-collect No. in the Application Form.
3. The candidate will download/print the filled Application form and paste a photograph on the available space and place his/her signature on the Application Form.
4. The candidate will attach all the relevant certificates/annexures and Challan Form with the Application and sent the same to the **Registrar, PGIMER, Sector-12, Chandigarh**.
5. **One envelop shall contain only a single Application Form.**

## **INTRODUCTION**

The Government of India in the Ministry of Health set up a committee known as the "HEALTH SURVEY AND PLANNING COMMITTEE" on the 12<sup>th</sup> June, 1959 to undertake the review of the development that had taken place since the publication of the report of HEALTH SURVERY DEVELOPMENT COMMITTEE (BHORE COMMITTEE) in 1946 with a view to formulate further health programmes for the country in the third and subsequent five year plan periods. This committee recommended the setting up of six Postgraduate Medical Institutions in the country one each at Calcutta, Mumbai, Madras, Hyderabad, Lucknow and Chandigarh to meet the increasing demand of teachers for the rapidly expanding medical colleges specialist services for hospitals, and need of the armed forces.

The Postgraduate Institute of Medical Education & Research was conceived and planned in 1960 to create in Chandigarh "ISLAND OF EXCELLENCE" providing physical and intellectual milieu for young scientists working in multiple disciplines of medicine, to advance the frontiers of knowledge render humane service to sick and suffering and to train medical and paramedical manpower. The Institute was established in 1962 under the erstwhile state of Punjab. It was declared as an Institute of national importance by an Act of Parliament (Act 51 of 1966) w.e.f. 1<sup>st</sup> April, 1967.

## **AIMS AND OBJECTIVES OF THE INSTITUTE**

The following are the aims and objectives of the Institute:-

- a) To develop patterns of teaching in undergraduate and postgraduate medical education in all its branches so as to demonstrate a high standard of medical education.
- b) To bring together as may be, in one place educational facilities of the highest order for the training of personnel in all important branches of health activity and;
- c) To attain self-sufficiency in postgraduate medical education to meet the country's needs for specialists and medical teachers.

## **ADMISSION TO THE COURSE**

- i) Admission to the Fellowships PGI is made twice in a year excluding Fellowship PGI (Medical Parasitology and Medical Biotechnology). The sessions commences from 1<sup>st</sup> January/July each year.
- ii) The admission to the courses imparted at the Institute is made on merit on all India basis by holding an entrance examination by the Institute, after issuing a countrywide admission notice. The admission notice is published in leading English Newspapers of India usually during September/October and February/March for January/July session respectively.

**NB: BEFORE APPLYING FOR COURSE CANDIDATES ARE ADVISED TO GO THROUGH THE INFORMATION BROCHURE AND THE ADMISISON NOTICE PUBLISHED IN THE PRESS CAREFULLY.**

## **QUALIFICATION REQUIREMENT**

### **Fellowship PGI (Cytopathology):**

MD (Pathology) passed or its equivalent qualifications from the University/ Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council.

### **Fellowship PGI (Vascular Neurosurgery):**

M.Ch. (Neurosurgery) passed from the University/Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council.

### **Fellowship PGI (Immunopathology):**

Only deputed candidates having MD degree in Medical Sciences/M.V.Sc. from the University/Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council.

### **Fellowship PGI (Interventional Radiology):**

MD (Radiology) or its equivalent degree from the University/ Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council. Two years of post MD experience as Senior Resident or equivalent.

### **Fellowship PGI (Musculoskeletal Radiology):**

MD (Radiology) or its equivalent degree from the University/ Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council. Two years of post MD experience as Senior Resident or equivalent.

### **Fellowship PGI (Renal Transplantation):**

MS (General Surgery) or its equivalent degree from the University/ Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council. One year experience as Senior Resident or equivalent.

### **Fellowship PGI (Breast Surgery):**

MS (General Surgery) or its equivalent degree from the University/Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council. Two years Senior Residency in General Surgery or two years work experience in General Surgery after M.S.

**Fellowship PGI (Head & Neck Oncosurgery):**

MS (Otolaryngology and Head & Neck Surgery) degree from any University/ Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council. Two years Senior Residency in ENT is essential after MS (ENT).

**Fellowship PGI (Paediatric Anaesthesia & Perioperative Critical Care):**

MD (Anaesthesia) or its equivalent degree from any University/ Institute recognized by the Medical Council of India. The candidate must be registered with National/State Registration Council. One year experience as Senior Resident.

**METHOD OF SELECTION**

**Fellowship PGI (Cytopathology):**

There will be an entrance test carrying 100 objective type questions (100 marks) in the subject of Pathology and related specialties. The candidates who secure atleast 50% marks will qualify for the counseling.

**Fellowship PGI (Vascular Neurosurgery):**

There will be an entrance test with 80 objective type questions for knowledge of Vascular Neurosurgery/General Neurosurgery (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practice/viva voce examination for 20 marks (Total 100 marks).

**Fellowship PGI (Immunopathology):**

There will be an entrance test with 80 objective type questions in the subject of Biology (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practice/viva voce examination for 20 marks (Total 100 marks).

**Fellowship PGI (Interventional Radiology):**

There will be an entrance test with 80 objective type questions related to Part-1 Radiodiagnosis & Imaging (50%) and Part-II Interventional Radiology (50%), (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practical examination for 20 marks related to Interventional Radiology which will include spot the diagnosis, viva and short case (Total 100 marks).

**Fellowship PGI (Musculoskeletal Radiology):**

There will be an entrance test with 80 objective type questions related to Part-I Radiodiagnosis & Imaging (50%) and Part-II Musculoskeletal Radiology (50%) (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practical examination for 20 marks related to Musculoskeletal Radiology which will include spot the diagnosis, viva and short case (Total 100 marks).

**Fellowship PGI (Renal Transplantation):**

There will be an entrance test with 80 multiple choice questions on the basis of entrance examination similar to the conducted for M.Ch. course of this Institute (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practical examination for 20 marks (Total 100 marks).

**Fellowship PGI (Breast Surgery):**

There will be an entrance test with 80 multiple choice questions related to General Surgery and Breast Diseases alongwith basic sciences as applied to Breast Diseases (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practical examination for 20 marks (Total 100 marks).

**Fellowship PGI (Head & Neck Oncosurgery):**

There will be an entrance test with 80 multiple choice questions (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practical examination for 20 marks (Total 100 marks).

**Fellowship PGI (Paediatric Anaesthesia & Perioperative Critical Care):**

There will be an entrance test with 80 multiple choice questions related to general and Paediatric Anaesthesia (80 marks). Those candidates obtaining minimum 50% marks will qualify for a departmental practical examination for 20 marks (Total 100 marks).

**Note:**

- i) There will be negative marking to the tune of 0.25 marks for each wrong answer in the theory paper.
- ii) The duration of the theory paper will be 1 ½ hours.

## **INTER-SE-MERIT**

If two or more candidates obtain equal marks in the entrance examination then their inter-se-merit for admission to the course shall be determined on the basis of the following:-

- i) A candidate who has made more attempts in passing examination would rank junior to a candidate who has made lesser attempts.
- ii) If the attempts made in passing examination are also the same, then a candidate who has obtained higher marks in the MBBS examination will rank senior to a candidate who has obtained lesser marks.
- iii) If the attempts made in passing the said examination and the marks obtained in the examination are also the same, then a candidate senior in age will rank senior to the candidate junior in age.

## **INSTRUCTIONS FOR SPONSORED/DEPUTED CANDIDATES**

A candidate applying for admission under sponsored category is required to furnish the following certificates from his/her employer for admission to the course:-

- i) That the candidate concerned is a permanent or regular employee of the deputing/ sponsoring authority.
- ii) That after getting the training at PGI, Chandigarh the candidate will be suitably employed by the deputing/sponsoring authority to work in the specialty in which the training is received by the candidate at PGI, Chandigarh.
- iii) That no financial implication in the form of emoluments, stipend etc. will devolve upon PGI, Chandigarh during the entire period of his/her course. Such payment will be the responsibility of the sponsoring/deputing authority.

**Note : Deputation/Sponsorship from private Institute/Hospital/Nursing Home shall not be accepted.**

## **LEAVE**

The candidates are entitled to 30 days leave during the course, in addition to weekly off days.

## **AGE LIMIT**

The age should not be more than 35 years and there is age relaxation of 5 years for sponsored candidates.

## **EXAMINATION**

At the end of the year, the candidates will be examined both in theory and practical examination. Internal Assessment will be made from day to day work and its evaluation after posting in different labs/departments. Successful candidates will be presented a certificate to the effect that the candidate undertook one year training in respective departments.



## **DETAILS OF FEES AND OTHER DUES**

The following fees etc. will be payable by candidates admitted to the course:-

Fees and other charges once paid shall not be refunded in any case including that of a candidate leaving the course before completion of the term or not joining the course for any reason. No correspondence in this connection will be entertained. However, Security will be refunded to the candidate who do not join the course. The refund of the security must be claimed within three years of the date of completion/discontinuation of the course, failing which the amount will be forfeited.

## **JOINING TIME**

Selected candidates must join their respective courses on the prescribed date, as indicated in their admission letters. The selection of those who fail to join by the specified date shall automatically stand cancelled. Under exceptional circumstances, a candidate may be allowed to join later upto two weeks on the condition that he/she will have to make up the deficiency by working for the same number of days by which he/she joins late, after the date on which his/her period of training would have otherwise been completed but for his/her late joining. The admission closes on 31<sup>st</sup> January & 31<sup>st</sup> July.

## **HOSTEL ACCOMMODATION**

No Hostel Accommodation will be provided.

## **GENERAL INFORMATION**

- a) The candidates will fill his application form available on the PGIMER website and will also take out a print of Challan form (triplicate) and application form and deposit the application fee in any State Bank of India branches all over the country. Those candidates who have SBI account can also pay their fee through i-collect service of SBI. In that case the INB reference No. will be generated and will have to be mentioned instead of Challan No. as reflected in the application form. The Challan form is needed to be filled up in the name of Director, PGIMER, Chandigarh (Examination) in the Power Jyoti Account No. **32211613319** and those candidates who have SBI account can also pay their fee through i-collect service **Account No. 32222954695**. Candidates should ensure that they have retained a copy of Challan with them and another copy of Challan deposited with the bank is attached with the application form sent to Registrar PGI, Chandigarh on or before **04.04.2014 upto 5.00 PM**.

- b) The complete application must reach the office of the **Registrar, PGIMER, Sector-12 Chandigarh** of this Institute either by post or by personal delivery at the counter on or before the closing date. Applications may please be sent preferably by registered post. For facility of candidates, the closing date for the receipt of applications has been mentioned on the application form. The counter for receipt of applications to be delivered personally will close at **5.00 P.M.** on the closing date as mentioned in the advertisement and no application will be received thereafter. The Institute will not be responsible if applications are delivered to any other quarters. The fact that the application registration No. has been issued to the candidates, does not mean that the application is complete in all respects and has been accepted by the Institute.
- c) Applications received after the closing date will not be considered. The Institute takes no responsibility for any delay in the receipt or loss of application in transit.
- d) Incomplete applications are not entertained. All particulars in the application form must be written carefully and legibly. All claims made in the application must be supported with documentary proof.
- e) Candidates, who have obtained, MD degree from the Medical Colleges which are not recognized by the Medical Council of India are not eligible to apply.
- e) Candidates should sign all the documents forming enclosures to the application and also put the date.
- f) The candidates should enclose with their applications two stamped @ Rs. 10/- each, self addressed envelopes of size 23x10 cms. Envelopes will be used for sending roll number, selection letters etc. Therefore, the address on the envelope should be legible, neat and complete.
- g) The candidates must forward their applications through proper channel. In case delay is anticipated in the transmission of the applications, an advance copy of the application on the prescribed form complete in all respects including the prescribed application fee must reach the Registrar of this Institute before the closing date. The application through proper channel should also reach the Registrar of the Institute within ten days after the last date fixed for the receipt of applications.
- h) The number of vacancies wherever indicated is provisional and may be reduced without prior notice.
- i) The decision of the Director of the Institute in the matter of selection of candidates for the various courses shall be final.
- j) The candidates invited for the selection may have to stay at Chandigarh 2-3 days. No TA/DA is admissible to them for the purpose.
- k) Any attempt on the part of the candidate to influence directly or indirectly will be treated as disqualification.
- l) A selected candidate shall have to pay the fees etc. on the same day failing which his/her selection will be treated as cancelled and the seat will be offered to the next on the waiting list in the order of merit.

- m) Private practice in any form during the course is prohibited.
- n) Good messing arrangement exists.
- o) The Institute is well equipped and staffed by faculty recruited from all over the country.
- p) There is well stocked and upto date library and large number of professional journals and periodicals are subscribed to for use by the faculty and the residents/students.
- q) The period of training is strictly full time and ordinarily continuous at the Institute.
- r) No individual intimation is sent to the unselected candidates and no correspondence on the subject is entertained.
- s) The rules are subject to change in accordance with the decision of the Institute from time to time.
- t) If the closing date fixed for the receipt of applications by the Institute is declared as a holiday or half holiday by the Chandigarh Administration, then the immediate next working day shall be the closing date for receipt of applications.
- u) If any entrance examination/interview is fixed for any course, there will not be any change in the date and the examination/interview will be held as per schedule even if the day is declared as a holiday or half holiday by the Chandigarh Administration.
- v) If any candidate has to seek any clarification or wants a duplicate Roll Number/Admit Card to be issued, then he/she must do so by seeing the Registrar of the Institute on a working day during office hours atleast a day prior to the date fixed for the theory examination. For obtaining a duplicate Roll Number/Admit Card, the candidate is required to furnish his/her recent passport size photograph. No documents etc. is entertained at the examination centre and no duplicate roll number/admit card is issued at the examination centre. The Centre Superintendent admits only those candidates to the examination whose candidature is confirmed.

#### **PROCEDURE TO BE FOLLOWED FOR THE ENTRANCE EXAMINATION**

1. All the candidates are required to bring their Admit Cards.
2. No candidate will be allowed to take the examination without producing the Admit Card.
3. They are required to be seated on their respective seats 30 minutes before the commencement of examination.
4. Vediography/Still Photography will be done during the examination, whereas Biometric finger print capturing will be done during examination, at the time of counseling and at the time of joining the course.
5. No material/paper including the envelope of the Admit Card is allowed in the examination hall.
6. Mobiles, Pagers or Calculators are strictly prohibited in the examination hall. Please arrange to keep them outside.

7. All the candidates are advised not to copy any question on a piece of paper/hand etc., if found copying down the questions from the question paper, the candidates will be booked under the UNFAIR MEANS CASE and his examination will be cancelled.
8. If any candidate is found guilty of any breach of the rules mentioned in the prospectus or guilty of using UNFAIR MEANS, he/she will be liable to be punished by the competent authority.

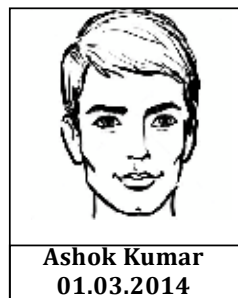
